# The effect of deprivation on access to hearing health care services in Wales

# **Background information**

By looking at patient records for adults at Abertawe Bro Morgannwg University (ABMU) Health Board it was found that the most deprived people experienced hearing loss at younger ages, but waited longer before seeking help than people living in more affluent areas.

This project plans to:

 Look at all seven Welsh health boards to provide a national picture of all those seeking the help of hearing services.

- To measure levels of hearing loss in the Welsh population, compare it to the numbers of people getting help for hearing problems and ask people about the barriers to getting help for hearing problems.
- look at access to NHS hearing services before and after COVID-19

## What is required?

5-10 people to

- give opinions on the development of the research project; identify research priorities / outcomes that are important to the public
- Provide feedback on public facing material (e.g. questionnaire)
- Comment on study conduct (e.g. ensure that the methods proposed for the study are acceptable and sensitive to the situation of the research participants)

If the application for funding is successful different levels of involvement will be offered for all stages of the study through to dissemination of results. There may be opportunities to attend periodic meetings (3-4 per year) or review written documents and provide feedback (3-4 documents).

### What reward is offered for taking part?

The public involvement and engagement team will:

- Cover reasonable travel expenses and additional carer or child care costs, prior to project funding.
- Offer payment for time of up to £20 per hour prior to project funding (people can request less if they are in receipt of state benefits).

As a registered member of the community you will also have access to support from the public involvement and engagement team and the Health and Care Research Wales training programme.
