### Speaker Biographies

#### Dr Nicola Williams



Nicola has worked for Health and Care Research Wales for the last eight years. Prior to her role in Wales, Nicola was Deputy Director of Research & Development in a large acute trust in England and in parallel, worked as a policy and change advisor to the Welsh and UK Governments, and the Health Research Authority.

She was an active researcher for over 20 years, initially delivering research programmes in primary care and public health and subsequently leading a public health research unit. More recently has overseen the COVID-19 vaccine trial delivery programme in Wales. Nicola is also an experienced leadership coach, coach supervisor.

#### Mrs Ann Tunley

Ann is the Head of Approvals Support at the Health Research Authority and was previously the Head of the Research Ethics Service in England. Ann leads the Support Division which is responsible for the recruitment and support of REC members and is the Appointing Authority Lead on behalf of the HRA. Ann's team is responsible for overseeing quality assurance activities and outcomes within the Approvals Directorate and for working with colleagues across the UK to maintain UK wide frameworks for ethics review.

Ann has considerable experience in research ethics having worked in this sphere for over 30 years in a number of support and management roles both prior to the establishment of the HRA and within the HRA.

#### Dr Martin O'Kane



Martin O'Kane PhD MRPharmS is Unit Manager of the Clinical Trials Unit in the medicines Licensing Division of the Medicines and Healthcare products Regulatory Agency (MHRA). He studied pharmacy at University of Aston and after completing a PhD in pharmacology and post-doctorate neuroscience research project at the University of Glasgow, moved to Japan to work within the pharmaceutical industry.

He joined the MHRA in 2005 as a Pharmacopoeial Scientist within the British Pharmacopoeia and moved to the MHRA Clinical Trials Unit as a Pharmaceutical Assessor in 2007. He became Unit Manager of the Clinical Trials Unit in November 2015 and has been actively involved in development of new clinical trials policy, systems and procedures to facilitate robust, pragmatic and proportionate trials as well as maintaining the attractiveness of the UK as a trial destination following exit from the EU.

Most recently he has been involved in supporting expedited approval of, and guidance for, clinical trials for COVID-19 vaccines and therapeutics and supporting the recovery and resilience of non-COVID trials. He is a member of the UK-wide Clinical Research, Recovery, Resilience and Growth (RRG) programme delivering the recent ambitious vision for the future of clinical research delivery in the UK.

## Dr Chris Subbe



Chris is an Improvement Science Fellow and Consultant in Acute, Respiratory and Intensive Care Medicine, Betsi Cadwaladr University Health Board. He is a graduate of the University of Cologne, Germany, where he studied respiratory pathophysiology to become a doctor of medicine by thesis in 1994.

After working in the UK and Germany and volunteering for Médecins sans Frontières in Angola, he joined Betsi Cadwaladr University Health Board in 2006 as a Consultant in Acute, Respiratory and Intensive Care Medicine. In 2009, he also became an Honorary Senior Clinical Lecturer at the School of Medical Sciences at Bangor University. Chris is actively involved in research on the identification and safety of critically ill patients on general wards. "The development that I am most proud of is bringing clinicians and researchers together in a number of sustained national and international collaborations."

Most recently, his research group has developed a visual toolkit to identify patients at risk and a set of crisis checklists for health care team interactions, as well as developing feedback systems for acute medical units and rapid response systems. He recently received the Patient Impact Award at the Betsi Cadwaladr University Health Board's Research and Innovation Excellence Awards 2021.

## Tom Fairman



Tom Fairman has worked for the HRA since 2011 in a variety of roles supporting ethics committee's and undertaking governance reviews for the purposes of HRA/Health and Care Research Wales Approval. Between 2014 and 2016 he worked for Cardiff and Vale NHS Foundation Trust in their R&D department liaising between researchers, the R&D office, relevant support departments and others to facilitate study submission and site set up. Tom moved into his current role, as Research Regulation Specialist at the beginning of 2021 and now works to develop future systems and processes to support research.

Astudiodd fferylliaeth ym Mhrifysgol Aston ac ar ôl cwblhau PhD mewn prosiect ymchwil ffarmacoleg ac ôl-ddoethuriaeth ym Mhrifysgol Glasgow, symudodd i Japan i weithio yn y diwydiant fferyllol.

Ymunodd â'r MHRA yn 2005 fel Gwyddonydd Ffarmacopoeial yn Pharmacopoeia Prydain a symudodd i Uned Treialon Clinigol MHRA fel Asesydd Fferyllol yn 2007. Daeth yn Rheolwr yr Uned Treialon Clinigol ym mis Tachwedd 2015 ac mae wedi chwarae rhan weithredol yn natblygiad newydd polisi, systemau a gweithdrefnau treialon clinigol i hwyluso treialon cadarn, pragmatig a chymesur yn ogystal â chynnwl atyniad y DU fel cyrchfan treialon ar ôl gadael yr UE.

Mae Chris yn Gymrawd Gwyddoniaeth Gwella ac yn Ymgynghorydd mewn Meddygaeth Gofal Acíwt, Anadlol a Dwys, Bwrdd Iechyd Prifysgol Betsi Cadwaladr. Graddiodd ym Mhrifysgol Cologne, yr Almaen, lle astudiodd pathoffisioleg resbiradol i ddod yn feddyg meddygaeth trwy draethawd ymchwil ym 1994.

Ar ôl gweithio yn y DU a'r Almaen a gwirfoddoli i Médecins sans Frontières yn Angola, ymunodd â Bwrdd Iechyd Prifysgol Betsi Cadwaladr yn 2006 fel Ymgynghorydd mewn Meddygaeth Gofal Acíwt, Anadlol a Dwys.
