### About these guidance notes

This document contains information and guidance to applicants submitting a **FULL** proposal to the Health and Care Research Wales Doctoral and Advanced Fellowship Award Scheme.

It is important that you read these guidance notes fully before starting to complete the application form to ensure that you provide the correct information.

We have endeavoured to cover all necessary information relating to the application form through these resources. Incorrectly completed applications may be rejected.

# Part 1: Background information

These guidance notes contain information relevant to Health and Care Research Wales Doctoral and Advanced Fellowship Schemes. Please read the guidance carefully to ensure that you are following the relevant information.

## 1. Introduction to the call

This integrated scheme offers a single point of entry for all applicants organised both by research stage (namely doctoral and post-doctoral) and by research focus (namely translational or clinical research and health and social care services or public health research). Where research is relatively early in the translational pathway, the potential for clinical and/or practical application and/or impact should be achievable within a reasonable timeframe. Please note that basic research or work involving animals or their tissue is not within scope. Medical Research Council (MRC) clinical and non-clinical fellowships schemes may be more appropriate for basic research or where animal costings are integral to the research proposal. Applications for Global Health research are out of remit.

This is a one-stage application process. An applicant may only submit one application to this call per round. Eligible applications considered competitive and within remit will first go through a shortlisting panel. The highest scoring applications will be invited to interview by the Panel.

Translational and clinical research applications at both doctoral and post-doctoral stages will be considered in one integrated panel and health and social care services and public health research applications at both doctoral and post-doctoral stages considered in a separate integrated panel.

### Doctoral Fellowship

This integrated scheme provides opportunities for health and social care researchers to undertake a PhD by research with full salary replacement.

The doctoral fellowship is for pre-doctoral researchers employed within Higher Education Institutes or NHS or social care organisations wishing to undertake a PhD by research either in

- a translational or clinical research topic or
- a health and social care services or public health research topic.

Applications should be submitted by the prospective PhD student with support from a PhD supervisor noted in the relevant section of the application form. Funding can be requested to cover directly incurred salary costs (no overheads or indirect costs allowable as per 3 Doctoral Fellowship Finance Guidance) of the applicant for 3 years' full-time funding, or 4-, 5-, or 6-years' part-time funding, their PhD tuition fees, and the costs of an appropriate research project and training and development programme.

## **Advanced Fellowship**

The Advanced Fellowship is for post-doctoral researchers at the mid-career researcher or senior researcher stage of their career. Applicants must have been awarded their PhD at the point of interview and may not hold a professorial level appointment at the commencement of award.

The Advanced Fellowship is an individual development award which offers funding for salary costs of the individual for up to 3 years' full-time funding, or 4-, 5- or 6-years' part-time funding, and the costs of an appropriate research project and training and development programme.

The scheme will fund high-quality research that supports personal career development in:

- translational or clinical research or
- health and social care services or public health research

Applicants will need to demonstrate the likely potential for clinical and/or practical application (if applying to the translational or clinical research panel) or how their work will benefit the public, health service practice or policy, service users and carers or social care and support services in Wales (if applying to the health and social services or public health research panel).

All Fellowship applicants are strongly advised to familiarise themselves with the resources available on the scheme's [webpage](#) as well as those from Health and Care Research Wales as a whole, including the Health and Care Research Wales Faculty, our [Research Community](#) and other support available. [Public Involvement](#) information and [award scheme webinars](#) are also available.

Successful applicants automatically become members of the Health and Care Research Wales Faculty. Being a member of the Faculty means having access to a range of learning, development and networking opportunities. All Faculty Personal Award holders will be expected to engage and contribute to, as well as benefit from the work of the Faculty. Applicants should explain how they will demonstrate active engagement with the Health and Care Research Wales Faculty.

Health and Care Research Wales approve and recommend the use of the Public Involvement in Research Impact Toolkit (PIRIT). We encourage researchers to incorporate use of the PIRIT tools in their work not only to support the planning of effective and meaningful public involvement in research in line with the [UK Standards for Public Involvement](#), but also to help track activity and showcase the impact that public members have on research. ## **1.1 Call remit**

The Doctoral Fellowship Award aims to support talented individuals to undertake research leading to the completion of a PhD and to support capacity building across translational or clinical research and health and social care services or public health research in Wales.

The Doctoral Fellowship offers funding for directly incurred salary costs (no overheads or indirect costs allowable as per 3 Doctoral Fellowship Finance Guidance) for 3 years' full-time funding, or 4/5/6-years' part-time funding, PhD tuition fees, and the costs of an appropriate research project and training and development programme.

Applications are invited from pre-doctoral researchers employed within Welsh Higher Education Institutions or NHS or social care organisations in Wales wishing to undertake a PhD by research in any translational, clinical, health, social-care or public health related discipline which will benefit the public, health service practice or policy, service users and carers or social care and support services in Wales. Applicants must demonstrate that they are/will be based and employed within Wales; proposed award plans should include a clear focus on Wales which extends beyond the agreement of a Welsh organisation to host the applicant. Proposals for PhD by Publication and Professional Doctorates are not in the remit of this scheme.

Current WCAT trainees can apply for project costs only (as salary and PhD student fees are supported by the WCAT scheme). Project consumables costs are not expected to exceed £60,000 over the course of the Fellowship.

Projects that are undertaken under this scheme are expected to have likely potential for clinical and/or practical application (if applying to the translational or clinical research panel) or benefit to the public, health service practice or policy, service users and carers or social care and support services in Wales (if applying to the health and social services or public health research panel). All projects should have clear relevance to Welsh Government policy priorities (see 1.2 Need and importance).

The Advanced Fellowship Award aims to support individuals to become independent researchers through leading and undertaking high-quality research across translational or clinical research and health and social care services or public health research in Wales.

The fellowship offers up to 3 years' full-time funding, or 4/5/6-years' part-time funding, to individuals who have been awarded their PhD (at the latest by the point of interview) and do not hold a professorial level appointment at the commencement of award.

Applications are invited from individuals working across any translational, clinical or health- or social-care- or public health related discipline to undertake research which will benefit the public, health- or social-care- or public health practice or policy, service users and carers or social care and support services in Wales. Applicants must demonstrate that they are/will be based within Wales; proposed plans should include a clear focus on Wales and Welsh Government policy priorities (see 1.2 Need and importance) which extends beyond the agreement of a Welsh organisation to host the applicant.

The research element of the Fellowship should have likely potential for clinical and/or practical application (if applying to the translational or clinical research panel) or benefit to the public, health service practice or policy, service users and carers or social care and support services in Wales (if applying to the health and social services or public health research panel).

Evidence syntheses and meta-analyses can be incorporated within applications. Projects focused on pilot and feasibility work, or the early stages of intervention development where knowledge obtained from these preliminary studies will inform future larger scale studies, are eligible.

All applicants are expected to clearly articulate the likely impact of their findings in the short to medium term.

## **1.2 Need and importance**

The Fellowship scheme offers funding opportunities across a broad range of translational or clinical and health services and social care-related or public health topics. All applicants will need to make a strong case for the need for and importance of their research proposal. This will include:

- a clear description of the clinical/health services/public health/social care/wellbeing need that the research is addressing and justification of the importance of that need, in terms of the scale of the problem and/or likely impact on those with the health or care need they are addressing
- the placing of the research proposed in the appropriate translational or clinical pathway or policy or practice context

- a description of how the research question was identified and developed and by whom
- details of how the public research partners such as patients/service users and/or carers have been involved in defining questions, design, outcomes and approach to knowledge transfer
- demonstration that the methods proposed are suitable for answering the research question
- an explanation of how equality, diversity and inclusion have been taken into consideration when formulating the research question, and how the project address or contribute to equality, diversity and inclusion issues

### 1.3 Eligibility

#### Doctoral Fellowship

Applications for a fellowship term of up to 6 years in duration and Whole Time Equivalent (WTE) of between a minimum of 50% and a maximum of 100% will be accepted - see criteria below. If the application is successful, a contract for the delivery of the research will be placed with the host organisation and all funds for the research will be issued to that organisation.

Applicants must satisfy the following criteria:

- applicants must be based at an institution or organisation in Wales at the time of applying (or be in receipt of a job offer such that they will be based at a host institution in Wales at the time the Fellowship starts)
- applicants will need to be able to undertake their award for up to three years (full time) or up to six years (part time) with a Whole Time Equivalent (WTE) of between a minimum of 50% and a maximum of 100% (full time). The maximum term of part-time awards should be proportionate to 3 years full time, with shorter terms also permitted. The cost of the whole award will not exceed £300,000
- applicants must be supported by a named PhD supervisor
- applicants must be in a position to commence activities by 1 October of the relevant year of the award
- applications must have the support of the Host Institution and any other organisation integral to delivery of the research
- where already registered for a PhD (or MPhil with transfer to PhD), applicants should not have been registered for more than 12 months at 100% WTE by the time the award starts
- unless otherwise indicated (e.g. through an advertised partnership between Health and Care Research Wales and another research funder) applicants must be entirely

funded through the Doctoral Fellowship for the duration of the award for the WTE that they have applied for

- applicants must have provided clear and comprehensive information and appropriate costings in all relevant sections of the application form including the training and development programme and public involvement and engagement plans
- applicants applying for a full-time Fellowship who are active clinicians or practitioners can dedicate an appropriate proportion of time to ensure maintenance of clinical or practice competencies. This is usually no more than 20% of your full-time role.

## **Advanced Fellowship**

Applications for a fellowship term of up to 6 years in duration and Whole Time Equivalent (WTE) of between a minimum of 50% and a maximum of 100% will be accepted - see criteria below. If the application is successful, a contract for the delivery of the research will be placed with the host organisation and all funds for the research will be issued to that organisation.

Applicants must satisfy the following criteria:

- applicants must be based at an institution or organisation in Wales at the time of applying (or be in receipt of a job offer such that they will be employed by a host institution in Wales at the time the Fellowship starts)
- applicants will need to be able to undertake their award for up to three years (full time) or up to six years (part time) with a Whole Time Equivalent (WTE) of between a minimum of 50% and a maximum of 100% (full time). The maximum term of part time awards should be proportionate to 3 years full time, with shorter terms also permitted. The cost of the whole award will not exceed £600,000
- applicants must hold a research PhD
- Health and Care Research Wales will also accept applications from applicants who have submitted their PhD thesis, or equivalent, to their institutions for assessment, provided they have been awarded their PhD by the point of interview
- applicants must not hold a professorial level appointment at the commencement of award (this does not apply to the title of honorary professor)
- applicants must be supported by a named academic mentor
- applicants must be in a position to commence activities by 1 October of the relevant year of the award
- applications must have the support of the Host Institution and any other organisation integral to delivery of the research
- applicants must have provided clear and comprehensive information and appropriate costings in all relevant sections of the application form including the training and



development programme and public involvement and engagement plans

- applicants applying for a full time Fellowship who are active clinicians or practitioners can dedicate an appropriate proportion of time to ensure maintenance of clinical or practice competencies. This is usually no more than 20% of your full time role
- individuals are eligible to be awarded up to two Advanced Fellowships sequentially, not normally totalling more than 6 years 100% WTE of funding
- applicants may have successfully held up to two previous Health and Care Research Wales funded post-doctoral awards upon application to this scheme. This may include Advancing Researcher, Next Steps and Advanced Fellowship awards.

## 1.4 Structure and Timetable

### Doctoral Fellowship

The assessment process is as follows:

- all applications are initially reviewed to check they are within the programme and call remit (including policy relevance) and to identify any that are clearly not competitive\*
- applications are prioritised by the Shortlisting Panel based on the assessment criteria for funding (Section 1.5)
- shortlisted applicants will be called for interview where they will be asked to provide a short presentation and answer questions from the Panel
- the Panel makes funding recommendations to Health and Care Research Wales

\* 'Not competitive' means that a proposal is not of a sufficiently high standard to be taken forward for further assessment in comparison with other proposals received, because it has little or no realistic prospect of funding. This may be because of scientific quality, cost, or scale/duration. Please note that appropriate and high-quality public involvement is an expectation of all applications which will be considered in the eligibility checks.

### Advanced Fellowship

The assessment process is as follows:

- all applications are initially reviewed to check they are within the programme and call remit (including policy relevance) and to identify any that are clearly not competitive\*
- applications are prioritised by the Shortlisting Panel based on the assessment criteria

for funding (Section 1.5)

- shortlisted applications will be sent out for expert and public review where this is deemed necessary prior to the applicant being called for interview by the Panel
- applicants will be asked to provide a short presentation and answer questions from the Panel
- the Panel makes funding recommendations to Health and Care Research Wales

## 1.5 Assessment criteria for funding

Applications will be subject to examination to ensure fit with the scheme's remit and eligibility conditions. Applications not progressed beyond this initial triage will be informed in writing.

Applications passing the triage stage will be reviewed by the Health and Care Research Wales Shortlisting Panel that will assess the all-round quality and merit of the project, the applicant and their potential to develop their research career (the person) and the proposed host research environment (place) along with the training and development programme. Shortlisted applicants will be invited to interview with the Panel.

Applicants will be expected to demonstrate evidence of relevance to the public and/or service user community; feasibility of practical application; likely benefit and value for money.

Applicants must also clearly justify the appropriateness, soundness and demonstrate rigour in methodology and design. The peer review process aims to utilise translational and clinician

experts, health and social care practitioners and academic reviewers, public members and service users within the Panel and will seek expert review outside of the Panel as needed. Public members and service users will have a specific focus on reviewing the quality of public involvement in the application.

The applicant will need to describe how they will communicate their results or report on expected findings in such a way that the research outcomes are open to critical examination by peers. Outputs are likely to take the form of both peer-reviewed academic publications, and publications or other outputs designed to reach a wide practitioner and service user audience. Outputs are expected to influence the ways in which clinical, health and/or social care services are delivered.

The Panel will make funding recommendations to Health and Care Research Wales (Welsh Government). Health and Care Research Wales (Welsh Government) will make the final funding decisions, considering the strength of Panel recommendations and available resources. These decisions are final and are not open to appeal.

Health and Care Research Wales Faculty expects to inform all applicants of the outcome in June 2026.

Therefore, sufficient time should be factored in for them to respond before the submission deadline.

The employing organisation will usually be the organisation with which the Science, Research and Evidence Division in Welsh Government will enter into a formal contract should your application be successful. Please confirm the type of contract you hold with them (fixed term or permanent) and the Line Manager details.

If the proposed contracting organisation is different to the current employing organisation, applicants should be in receipt of a job offer such that they will be employed by the contracting organisation in Wales at the time the Fellowship starts. In this circumstance, the type of contract you will hold with them (fixed term or permanent) should be confirmed, and the Line Manager details.

## Section B: Project summary

### B1 Research title

(Limit: 200 characters)

The project title should clearly and concisely state the proposed research. Any abbreviations should be spelled out.

### B2 Research activity code

UKCRC Research Activity Codes classify types of research activity. This dimension of the Health Research Classification System (HRCS) has 48 codes divided into eight overarching code groups

which encompass all aspects of health-related research activity ranging from basic to applied research. The [Research Activity Codes](#) are modelled on the structure of the Common Scientific Outline, a cancer research specific classification system developed by the International Cancer Research Partners.

- Detection screening and diagnosis
- Development of treatments and therapeutic interventions

### **B3 Award start date**

Please note this should be 1 October 2026, whether this is a working day or not. Alternative start dates will only be considered in exceptional circumstances.

In planning the fellowship start date, you will need to take account of the necessary contracting and recruitment time and any ethics approval you may need prior to starting your research.

Health and Care Research Wales is committed to timeliness of research and rapid initiation of studies following panel assessment. Please note that should you be successful with your proposal we will expect your fellowship to commence on the 1 October 2026.

If you find that your circumstances change during the assessment process, and that you may need an exception to the start date (for example, if you will be taking leave of any kind) you **must inform Health and Care Research Wales as soon as you are aware of this**. Health and Care Research Wales reserve the right to withdraw the funding offer should the applicant fail to inform them of any changes in circumstances in a timely manner.

### **B4 Award end date**



Your fellowship can be undertaken for up to three years (full time) or up to six years (part time) with a Whole Time Equivalent (WTE) of between a minimum of 50% and a maximum of 100% (full time). The maximum term of part-time awards should be proportionate to 3 years full-time, with shorter terms also permitted.

## **B5 Total award costs requested**

You should enter the figure calculated in your 4 Doctoral Fellowship Budget and Justification or 6 Advanced Fellowship Budget and Justification spreadsheet here. You should complete the separate appropriate Budget and Justification document and attach it as part of your application.

### **Doctoral Fellowship**

Please note, applicants wishing to collaborate with the SAIL databank should ensure they engage SAIL sufficiently in the development of their application. You should cost in the necessary data analyst or training time as a specified direct cost. This is also applicable if you are planning to engage with Clinical Trials Units or Health and Care Economics Cymru.

If you require NHS costs (As set out by [AcoRD guidance](#)), you must ensure they have been approved.

The cost of the whole award cannot exceed £300,000.

### **Advanced Fellowship**

Health and Care Research Wales will pay up to 80% of the Full Economic Cost (FEC) of the fellowship for Higher Education Institutes (HEIs). Up to 100% of costs requested for NHS organisations will be paid.

### **The importance of a plain English summary**

A plain English summary is a clear explanation of your research, free from jargon and acronyms. The plain English summary is not the same as a scientific abstract - please do not cut and paste this or other sections of your application form to create the plain English summary.

Many reviewers use this summary to inform their review of your funding application. They include clinicians and researchers who do not have specialist knowledge of your field as well as policy makers and members of the public. If your application for funding is successful, the summary may be used on the Health and Care Research Wales and other websites.

A good quality plain English summary providing an easy-to-read overview of your whole study will help:

- those carrying out the review (reviewers and shortlisting and interview panel members) to have a better understanding of your research proposal
- inform others about your research such as members of the public, health professionals, policy makers and the media
- the research funders to publicise the research that they fund

It is helpful to involve service users/carers/members of the public in developing a plain English summary.

Please note that the clarity of the plain English summary is assessed as part of the public reviewer assessment. If your plain English summary is considered poor, this may affect the funding decision. **If your application is considered strong enough in other ways to be funded but your plain English summary is poor, you will be asked to resubmit your plain English summary prior to funding approval.**

The rationale should aim to detail the:

- likely benefits of the proposed research to the health- or social-care- or public health

- practice or policy, service users and carers or social care and support service in Wales
- implications for the further development of health or social care or integrated social care and health or public health practice
- potential impact on organisational decision-making and improvements in service delivery

### **Background and rationale evidence:**

In addition to searching main bibliographic databases and research registers, applicants should check the list of existing research funded by [Health and Care Research Wales](#) and other major UK research funders.

Please describe the existing evidence base for this research and demonstrate why this means your research is important now, both in terms of time and relevance.

The proposed standard for what constitutes a satisfactory review of the existing evidence to inform new primary research is as follows:

It can be used to mention mentoring of members in your field and support you provided to the advancement of colleagues, be it junior or senior. You can also highlight the establishment of collaborations, from institutional (maybe interdisciplinary) to international and describe where you exerted strategic leadership, how you shaped the direction of a team, organisation, company or institution.

### **Contributions to the wider research community and the wider innovation community**

Describe various activities you have engaged in to progress the research community. Mention commitments including editing, reviewing, refereeing, committee work and your contributions

to the evaluation of researchers and research projects. Mention the organisation of events that have benefited your research community. Highlight contributions to increasing research integrity, and improving research culture (gender equality, diversity, mobility of researchers, reward and recognition of researchers' various activities). Mention appointments to positions of responsibility such as committee membership and corporate roles within your department, institution or organisation, and recognition by invitation within your sector.

### **Contributions to broader society, contributions to broader research or innovation-users and audiences, and towards wider societal benefit**

Include examples of societal engagement and knowledge exchange. Include engagement with industry and the private sector. Mention engagement with the public sector, clients and the broader public. It can be used to highlight positive stakeholder feedback, inclusion of patients in processes and clinical trials, and other impacts across research, policy, practice and business. Mention efforts to collaborate with particular societal or patient groups. It can be used to highlight efforts to advise policy-makers at local, national or international level and provide information through the press and on social media.

You can use sub-headings (personal statement, knowledge generation, development of individuals and teams, research community and broader society) to structure this section but it is not mandated.

Do not include details of your previous employment history as this is covered in Section E of the application.

## **Section H: References**

List all references cited in the application, using either the Vancouver or Harvard referencing conventions.

Any questionnaires or other documents that you have prepared to be used as part of your study should be available on request.

## **Section I: Suggested reviewers**

You may wish to provide details of two to three specialty experts who would be able to provide an independent assessment of your proposal. Please note that the reviewers must not be from your host institution, or those of your academic mentor. In addition, you should not have recently (within the last five years) collaborated with any of the nominated reviewers. It is permissible to nominate overseas experts.

Nominated reviewers who are acceptable to Health and Care Research Wales may be approached shortly after the submission deadline. If they are willing to assist, they will be supplied with a copy of your proposal, an assessment form and guidance notes, and will be given a two to three week period to complete their review.

## Section J: Acknowledgement

### J1 Agreement to the terms and conditions

In confirming your role as Applicant in this application you confirm that the information given in this form is complete and correct, and you take full responsibility for the accuracy of this submission. You confirm your academic mentor and Supporting Roles mentioned on this application have been given access to the application and accepted their role in this submission. You shall be actively engaged in, and in day-to-day control of, the project. You confirm you understand progress reports will be required by the funding programme and no substantive variation in the scheme as outlined in the application will be permitted without prior reference to the funding programme.

## Section K: Supporting documents

Please attach these supporting documents to your application form.

### K1 Budget and justification

Please use 4 Doctoral Fellowship Budget and Justification or 6 Advanced Fellowship Budget and Justification as appropriate for the detailed budget breakdown, there is separate guidance for its completion. This is a required document.

### K2 Excess treatment and support costs - Schedule of Events Cost Attribution Template (SoECAT)

Since October 2018, researchers applying for certain clinical research grants are required to complete a SoECAT as part of the grant application process. This allows funders to receive reassurance that the cost activities within the study have been attributed correctly in line with AcoRD. You must submit the SoECAT if you require NHS excess treatment costs for the conduct of your research. This is unlikely for Social Care applications.

### K3 Research plan or flowchart

Please attach a research plan or flowchart illustrating the study design and the flow of participants. This should be submitted in Microsoft Word and in portrait format and be one side of A4. This is a required document.

Applicants should describe complex interventions and controls as accurately and fully as possible within their diagram. If proposing an RCT, we advise you to refer to the [CONSORT statement and website](#) for guidance. Alternatively, you may find the [EQUATOR](#) Network website useful or the [ACCEPT paper](#) (Charlesworth et al. BMC Medical Research Methodology 2013, 13:78).

Please ensure that the plan or flowchart is clear and that any text is concise.

#### **K4 Letters of support**

Please note that where you have indicated engagement with a Clinical Trials Unit, we require a letter of support; this must be provided with your application.

If your proposed research project is dependent on the support of a different organisation to the host institution, a letter of support is required from the relevant R&D lead outlining their support of this application. Please note that if you propose to utilise SAIL or similar providers, confirmation of their agreement to support the research, with confirmation of costs, is required.

Health and Care Research Wales will not accept letters of support from Welsh Government officials. If these are included, they will be removed prior to assessment of the application.

All letters of support should be written on headed paper and signed by the appropriate signatory.

#### **Section L: Review and submit**

You must submit your application form, with the attached budget and justification document and any other supporting documents by the stated deadline via the Health and Care Research Wales Faculty Awards Management System.

Please note that the supporting team (supervisor/mentor, nominated Head of Department, organisational approver and Finance Officer as a minimum) will be required to confirm participation during the application process, and additionally, the organisational approver and finance officer will be required to sign off the completed application form before it can be submitted. Therefore, sufficient time should be factored in for them to respond before the submission deadline.

We will not enter into negotiations for extensions, and the deadline will be strictly observed. You should therefore plan your application carefully including allowing sufficient time for signatories to confirm their support.

# Annex

## Social Care Research guidelines: 'What is Social Care Research?'

### Introduction

In 2014, Health and Care Research Wales reviewed definitions of social care from a range of UK and international sources. A one-day workshop was also convened to develop guidelines on the question of 'What is Social Care Research?' The workshop involved a range of stakeholders from England and Wales including research academics, social care practitioners, and members of the public.

The results of the workshop were collated and condensed into a number of key areas. These were distributed to a subset of workshop attendees for further comments and feedback until a consensus was reached.

It is important to consider the following as guidelines and not a definition of social care research. It is inevitable that some research projects, especially those conducted at the interface of social care and health, will be difficult to categorise as clearly belonging to one category or the other.

### Guidelines

For Health and Care Research Wales to consider research to be 'Social Care Research', the research should broadly focus on at least one of the following:

- The provision of care, support, and personal assistance in the context of interpersonal relationships, whether formal or informal, in relation to: activities of daily living, maintenance of independence, social interaction, enabling the individual to play a fuller part in society, assisting individuals to manage complex relationships, and assisting the individual to access or receive services from a care home or other supported accommodation or to take advantage of educational facilities.
- The provision of: advice; practical assistance in the home; assistance with equipment and home adaptations; visiting and replacement care; meals; or facilities for occupational, social, cultural and recreational activities outside the home.
- The provision of: protection or social support services for children or adults in need or at risk, or those with social needs arising from illness, disability, age or poverty.
- The social needs of people receiving social care, and the services or initiatives addressing those needs, including: prevention of deterioration; promotion of physical or mental health; improving opportunities and life chances; strengthening families; and protecting human rights.

- The organisational systems, infrastructures, care settings, and/or personnel involved in the management and leadership, commissioning, provision, delivery, monitoring and evaluation of care and support services, and/or the interface between; or impact of the above on related systems such as healthcare, education, housing, and the criminal justice system.
- National and/or local policies that affect the ethos, commissioning, organisation, provision, monitoring and evaluation, and delivery of care and support services.
- The improvement of social and community cohesion (rather than the individual).

Useful questions that can help inform whether a research project is Social Care Research include:

- What is the research question?
- Why is the research required?
- What is the purpose of the research and who or what might benefit? (Eligible examples could be: service users, service providers, carers, social care practitioners, professionals and non professionals, patients, academics and family).
- What are the social (care) outcomes?
- What is the relevance of the application to Welsh Government social care policy?
- Who might read the research results? (e.g. social care practitioners, policymakers, or academics).
